5 Without prejudice to any antecedent right against the consumer including the right to take procceedings,
(a) No consumer shall use or is permited to use the sewerline except for such use as specified by him or her in this application.
(b) No consumer shall convey or be permited to convey by any means whatsoever, for use outside his/her plot for use unless approved by the company
6 The consumer shall meet all charges in respect of waste water in pursuance to this application .
7 The company shall have the right forthwith and without notice to terminate the agreement for any breach by the
consumer to the conditions of supply.
