INVITATION FOR APPLICATIONS FOR PERSONS WISHING TO REPRESENT STAKEHOLDERS IN THE BOARD OF DIRECTORS OF MATHIRA WATER AND SANITATION COMPANY

Mathira Water and Sanitation Company (MAWASCO) is a limited company wholly owned by the County Government of Nyeri. The company is a licensed water and sanitation services provider serving Mathira East and West Sub Counties and their environs as per Water Act 2016.

The Board of Directors comprises representatives of stakeholders identified in accordance with Corporate Governance Guidelines issued by WASREB.

The Company's Board of Directors has two (2) vacancies for directors to be filled by representatives of the following stakeholders:

- i) One (1) Director representing Resident/Community Organizations and Religious Organizations
- ii) One (1) Director representing Farmers Organizations

This is therefore to invite applications from nominees of the above stakeholders. The applicants should enclose a letter of nomination from the stakeholder organization/ institution together with their own applications and curriculum vitae (CV) including certified copies of academic, professional certificates and testimonials. The applicants must meet the eligibility criteria outlined below;

- i. Must have a minimum of a Bachelor's degree from a recognized university in Kenya
- Must have a minimum of seven (7) years working experience in the core professional or have run a registered own enterprise for a minimum of seven (7) years.
- iii. Demonstrate participation in local development initiatives
- iv. Experience as a change management agent
- v. Be a resident of the area served by the company.
- vi. Must meet WASREB 's FIT and PROPER test criteria (form can be downloaded from MAWASCO website)
- vii. Must meet the requirements of Chapter 6 of the constitution of Kenya 2010;

- a) Certificate of Good Conduct from Criminal Investigation Department (CID)
- b) Clearance Certificate from accredited Credit Reference Bureau (CRB)
- c) Clearance Certificate from Higher Education Loans Board (HELB)
- d) Tax Compliance Certificate from Kenya Revenue Authority (KRA)
- e) Clearance Certificate from Ethics and Anti-Corruption Commission (EACC)

NOTE

- Applicants must be nominated by a registered Stakeholder group within the company's area of supply and relevant to indicated vacancy.
- Suppliers and other trading associates of the Company are not eligible for Directorship positions of the company.
- 3. Persons in current professional or social relationships with Directors of the Company cannot become Directors in the Company
- Nominating organizations are encouraged to nominate women for considerations to ensure the one third gender rule as required under the constitution.
